*** Grade-Up registration, transfer, etc. will follow the same fee structure as listed above. All Grade-Up horses will be required to pull DNA. Please see the rules on the Grade-Up section of this website.

Delinquent Fee Schedule

Registrations

Registrations will be considered delinquent for new foals on June 1st the year following the year of birth. Registration of imported horses will be considered delinquent 180 days following importation. With the anniversary of the sale date on imported horses or June 1st on foals, fees will double the first year (\$100 for annual dues paying members, \$150 for members, and \$300 for non-members). Fees will double again on the second anniversary of sale date on imported horses or June 1st on foals, which will be the maximum amount for delinquent registration (\$200 for annual dues paying members, \$300 for members, and \$600 for non-members).

Transfers

Transfers are considered to be delinquent 90 days after the sale date and fees will double after that time (\$100 for annual dues paying members, \$150 for members, and \$300 for non-members). At the anniversary of the sale date, the transfer fee will double again, which will be the maximum fee for delinquent transfers (\$200 for annual dues paying members, \$300 for members, and \$600 for non-members). Remember, transfer fees are the responsibility of those **selling the horse**, not the buyer.

In-Family Transfer Definition:

A group of persons united by the ties of marriage, blood, or adoption, constituting a single household and interacting with each other in their respective social positions, usually those of spouses, parents, children, and siblings.

For example: Immediate family – grandparents, father, mother, brother, sister, and those by marriage (sister-in-law, & brother-in-law).
